School-based Program Model: Increase access for children to receive dental sealants and other evidence-based preventive services by creating or expanding school dental programs to reduce the burden of oral diseases. School-linked Program Model: Implement a robust community-clinical linkage system using a referral management electronic platform for connecting with parents and linking children to a source of dental care, tracking the progress of care from referral to completion of treatment plan.
